- Represent shares withheld to cover taxes due in connection with exercise of stock appreciation rights (see footnote 6).
- Reflects the sale of shares of Class A Common Stock effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person in December 2018 (the "Plan"). The Plan covers shares of Class A Common Stock to be acquired upon the exercise of 412,816 stock appreciation rights during the period commencing on January 22, 2019 and ending on January 15, 2020.
- The price reflects the weighted average of sales made at prices ranging from \$16.64 to \$16.74. The reporting person agrees to provide upon request by the Staff of the Securities and Exchange Commission, ANGI Homeservices or any security holder of ANGI Homeservices, information regarding the number of shares sold at each separate price.
- Represents 694,992 vested stock appreciation rights and 325,177 unvested stock appreciation rights that vest in one final installment on February 11, 2020, subject to continued service.
