The Plan covers shares of Class A Common Stock to be acquired upon the exercise of 412,816 stock appreciation rights during the period commencing on January 22, 2019 and ending on January 15, 2020.
- The price reflects the weighted average of sales made at prices ranging from \$16.77 to \$17.00.
